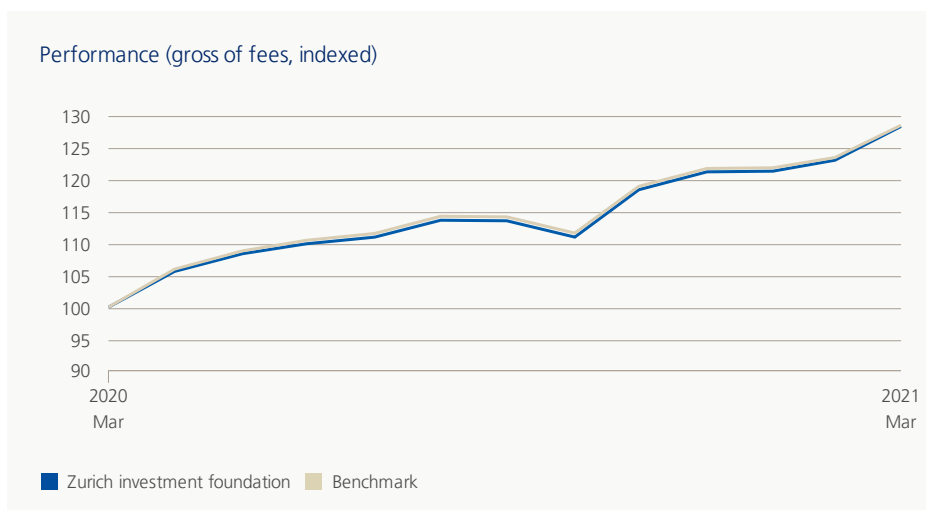


Mix 65 (not BVV 2 compliant)

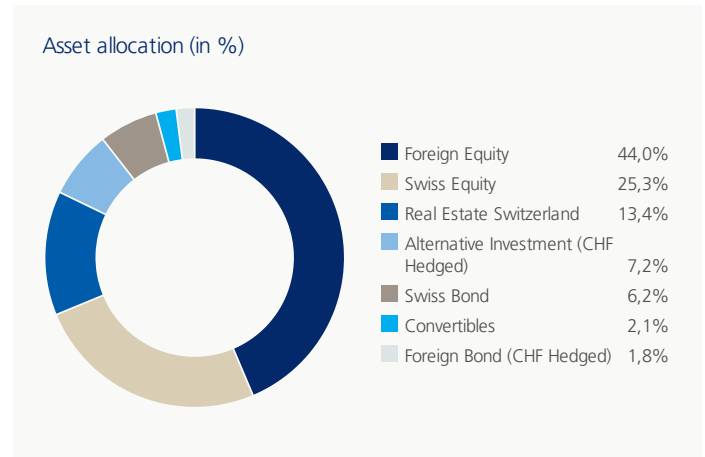
